## The San Diego Foundation Grant Recommendation Guidelines

Thank you for submitting your Grant Recommendation. Please be advised that in order to maintain its own tax-exempt status, The San Diego Foundation must review, approve, or decline grant recommendations. Listed below are a few guidelines to help you with your grant recommendation.

- The San Diego Foundation can only grant to qualified public charitable organizations (i.e. 501(c)(3), operating foundations, or governmental and educational institutions).
- Per IRS guidelines for Donor Advised Funds, The San Diego Foundation is not permitted to distribute grants to individuals, supporting organizations, or private non-operating foundations.
- Grant checks and award letters are made to the legal name of the grantee and mailed directly to its address.
- Grants must be used entirely for charitable purposes.
- Any grant that provides more than an incidental benefit to donors or fund advisors and/or their families is not permitted. Under the Pension Protection Act of 2006, monetary penalties apply to you personally if you receive a prohibited benefit or you recommended a grant which results in a prohibited benefit.
- To request a follow-up report for grants under \$50,000 (e.g. with special circumstances), please contact your Donor Manager.
- Final approval of grant disbursements resides with The San Diego Foundation's Board of Governors. Grants are presented to the Executive Committee each week through an approval poll. Grant recommendations must be submitted by noon on Thursday for inclusion in the current week's approval poll. Recommendations received thereafter will be submitted with the following week's approval poll.
- Grants meeting TSDF's due diligence requirements are generally mailed within 7-10 business days.
- For grants to international organizations, The San Diego Foundation must establish charitable equivalency per IRS guidelines for grants from Donor Advised Funds. Additional time and fees may be required to perform additional due diligence.
