Legacy funds at The San Diego Foundation are placeholders during your lifetime and are activated when a gift is received from your estate.

LEGACY FUND TYPES



ADVISED

Grants from your advised fund are recommended by a Fund Advisor. of your choosing This type of fund is best when you

want to designate a specific person to make grants from the fund on your behalf, typically a child or other close relative.



BROAD PURPOSE

Broad purpose funds support a chosen cause - for instance, arts & culture, protecting the environment, or support

for seniors. This type of fund is best if you are passionate about a specific focus area(s) but you do not want to choose specific organizations. This is particularly pertinent with legacy gifts that are endowments because grantmaking from your fund remains relevant in perpetuity. Our professional staff utilizes our deep community knowledge to choose nonprofit grantees that meet your wishes.



DESIGNATED

Designated funds support specific organizations that you choose during your lifetime. This type of fund is best when you

know the exact organizations you want to support, each of which receive a set percentage adding up to 100%. The number of grantees that can be supported depends on the anticipated size of your estate.



SCHOLARSHIP

Scholarship funds support students' academic pursuits, and are tailored to match the your interests. You provide

scholarship award criteria (for instance, desired GPA and/or extracurricular activities) and Scholarship Program staff and volunteers review applications on your behalf. Your friends and family can be included in the review process per your wishes.

ADVISED

The purpose of the fund shall be general charitable purposes. Upon receipt of assets, (Fund Advisor Name) shall be the advisor of the Fund (“Fund Advisor”). Upon the death, incapacity or resignation of the last surviving Fund Advisor, the Board of Governors of TSDf itself shall serve as the advisor of the Fund.

BROAD PURPOSE

- The purpose of the fund shall be to support health programs and social services for older adults.

 - The purpose of the fund shall be to support opportunities for low-income, underserved students in the fields of science, technology, engineering and math.

DESIGNATED

- The purpose of the fund shall be to support KPBS as to 25% of the distributions, Point Loma United Methodist Church as to 25% of the distributions, and The San Diego Foundation Fund for the Future as to 50% of the distributions.
 - The purpose of the fund shall be to support the Strong Families, Thriving Communities Program as to 33.3% of the distributions, Challenged Athletes Foundation as to 33.3% of the distributions, and Ocean Discovery Institute as to 33.3% of the distributions.

SCHOLARSHIP

The purpose of the Fund shall be to award scholarships to individuals residing in San Diego County who meet the following criteria:

- Graduating high school seniors who demonstrate a financial need and are the first in their families to pursue higher education
- Have a minimum unweighted 3.0 GPA on a 4.0 scale
- This scholarship may be renewable (depending on available funds). Recipients must maintain full-time enrollment and a minimum cumulative GPA of 3.0 on a 4.0 scale.
- This scholarship may be used for tuition, books, fees, and other educational expenses
