Monthly	Please follow the “Setting Up Automatic Bank Contributions” instructions below.

Setting Up Automatic Bank Contributions

1. Log in online to your bank account (i.e. www.wellsfargo.com) and click on Bill Pay.
2. Set up your CVCF as a payee. To set up, you'll need the company address and your account number.
 - Company Name: San Diego Foundation – CVCF
 - Address: San Diego Foundation - 2508 Historic Decatur Road, Ste. 200, San Diego, CA 92106
 - Account No.: [last name] CVCF Membership
3. Choose to set up automatic payments. Enter the payment amount and frequency.
4. Schedule your payment. Tell the bank the amount you want to pay, and when you want the money to be taken out of your checking account. Your bank will let you know how much time to allow for each payee - it's usually up to three to five business days before you want the money to get there.
5. Your payment is sent. The money is deducted from your account in the amount and frequency you set up and mailed directly to the foundation.
